A Good Board Member

Once a person has met the qualifications, been properly nominated, duly elected and officially sworn in, his or her real job begins. No one can know the various pressures, politics and satisfactions of such a position until he or she has served on a board of education.

We often hear that one person is a good board member or another is a bad board member, yet we seldom hear of a clear definition of what constitutes a "good" board member.

In reality, there are about as many philosophical theories about boardmanship as there are board members. However, there are some widely accepted guidelines. Members must recognize that seldom do two people react to the same problem in an identical manner, so flexibility is advised.

A good board member:

•Is legally a board member only when the board of education is in session? No one person, unless authorized by the public body, should speak on behalf of the board.

•Avoids administrative decisions or attempts to second-guess the administration. The superintendent is the chief executive officer and the treasurer is the chief financial officer in the district. The board has no administrative function.

• Is well acquainted with school district, as well as other local, state and federal educational policies.

• Should vote at all times in the best interest of the school district.

• Is flexible and realizes there are times when changes must be made, tradition cannot be honored and pressure must be ignored.

• Remembers that board business often requires confidentiality, especially in processes involving students, personnel, land acquisition, negotiations and the need for security.

• Is interested in obtaining facts, but remembers that the administration is responsible for operating the schools rather than spending a majority of its time making reports to the board or individual board members.

• Is a good listener at board meetings, on the street comer and/ or in the community, but never commits himself or herself, the board or the administration to any particular course of action.

Knows that the reputation of the entire school district is reflected in his or her behavior and attitude.Has a sense of humor and the ability to laugh at himself or herself when things look bleak.

• Is able to sift fact from fiction, sort out rumors from reality and know the difference. A gullible board member is ineffective.

• Is able to support all decisions when they have been made by the full board.

• Makes decisions based on the district's current vision, mission and goals.
